- Personal responsibility and behavior will help mitigate the rise.

Environmental Health Update - Jeff Nelson, Director

- Putting finishing touches on highlighting Environmental health is a primary entity or a support entity under the comprehensive emergency plan. Specifically outlining emergency support functions.
- How we can best support response support activity going forward especially relating to regulated facilities.
- Trends show gatherings resulting in increased transmission.
- DOH providing inspections of facilities while minimizing the time spent in these facilities.
- Educating establishments in how to best participate in reducing virus transmission.
- Monitoring the issue on schools in regards to opening and food delivery.

Incident Commander - Chief Leonard Johnson

- Isolation and Quarantine facilities requirements by the State and to manage disease activity.
- Provide facilities for those who cannot quarantine or isolate themselves if either suspected to have COVID-19 or have tested positive and have no place to shelter.
- Agreement Quinault Nation to use their Sweet Grass facility. Open since July 1,2020.
- Crisis clinic is moving forward with a 15 bed facility once completed to house isolation and quarantine. Should be completed by mid-September 2020.
- Ventilation and electrical improvements contracted with Robin's Air and Comcast.

• The Partnership with Quinault Nation has allowed us to bridge the gap from our previous facility to the harden facility.
