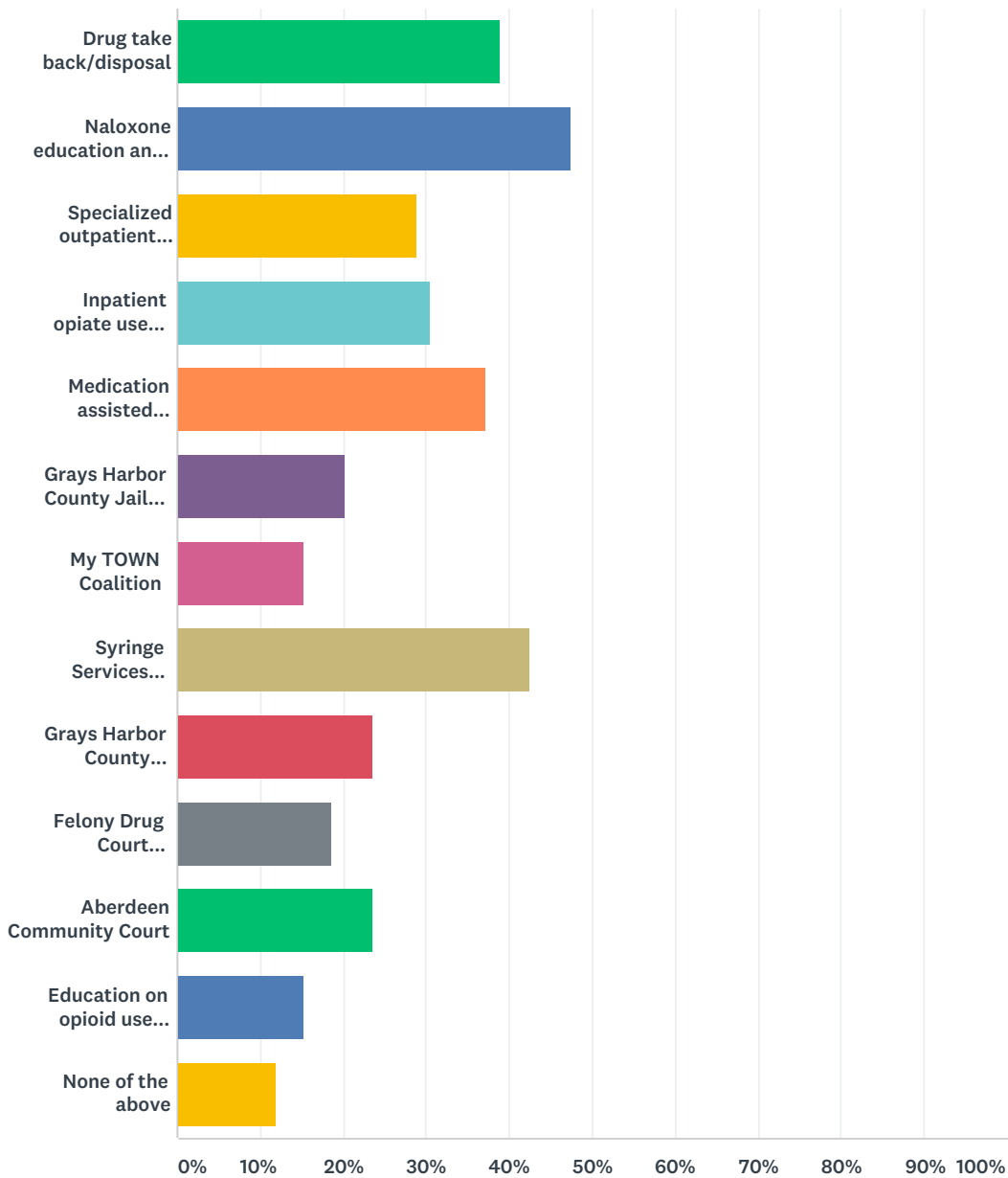


Q1 In the past 12 months, have you heard about any of the following opioid-related events or initiatives in our community?

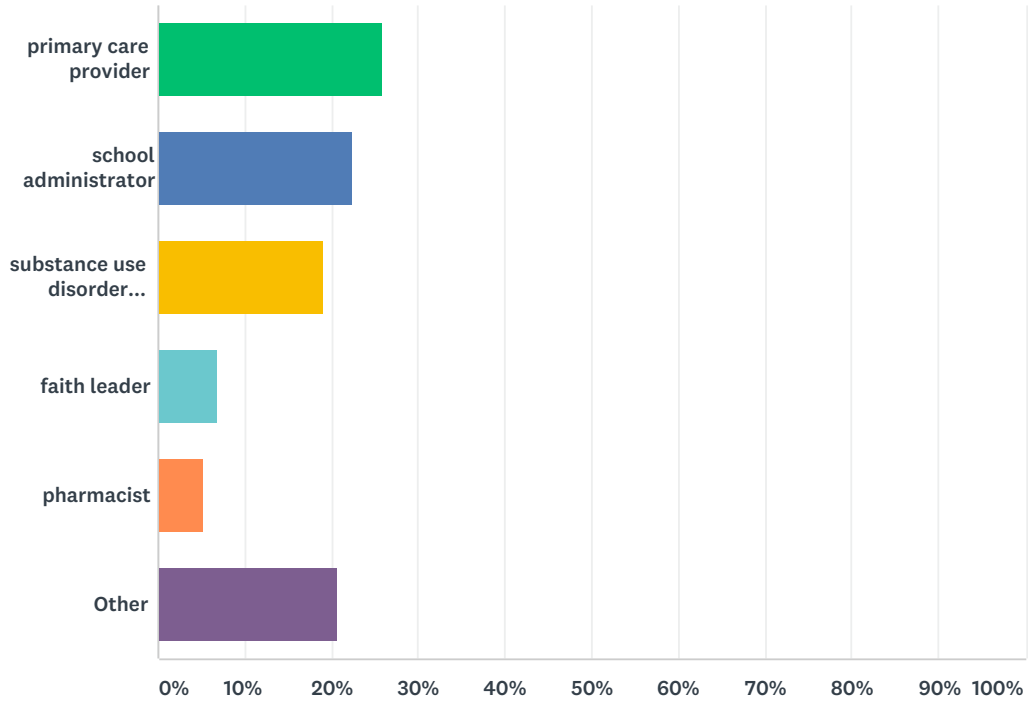

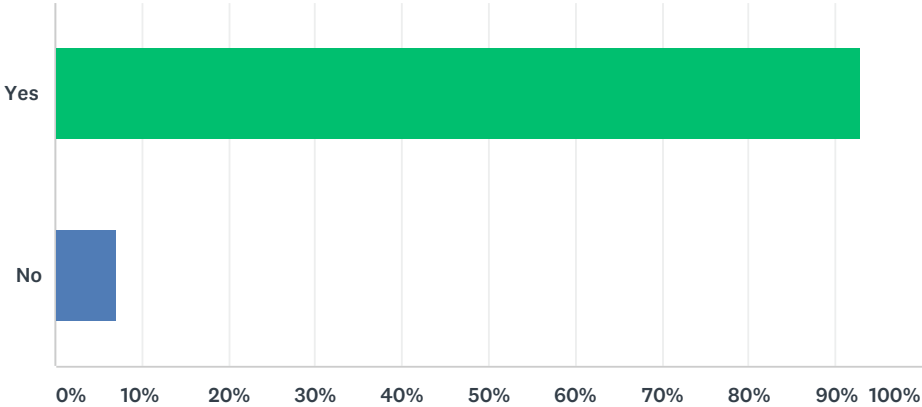

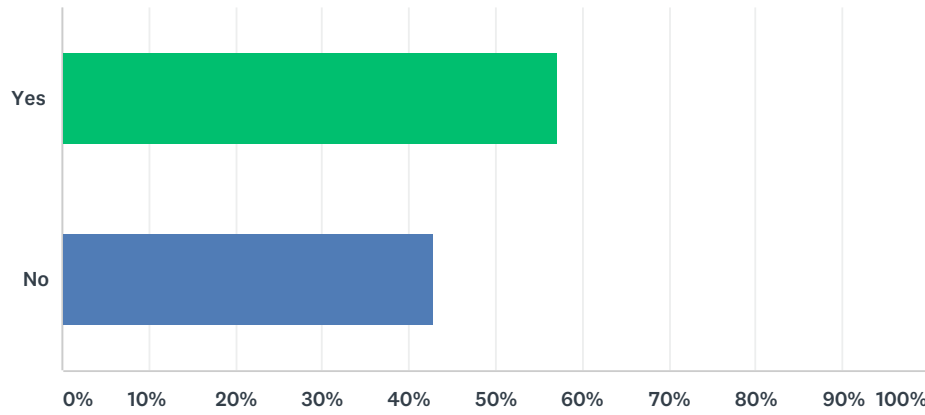

Q4 Do you use the PMP?

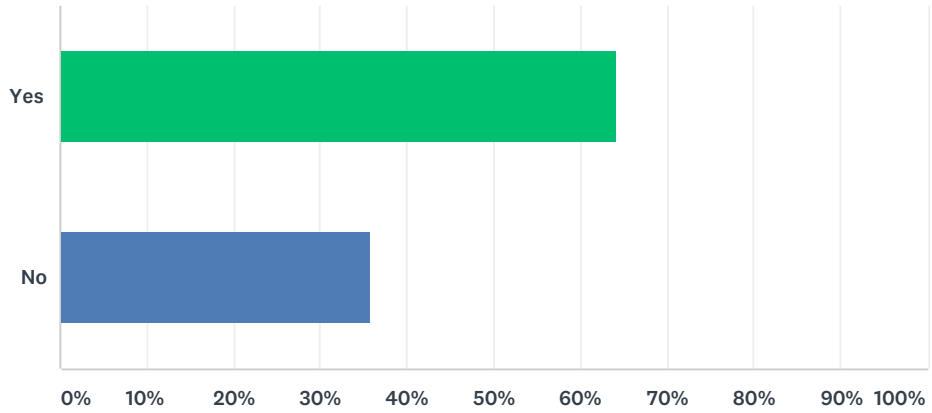

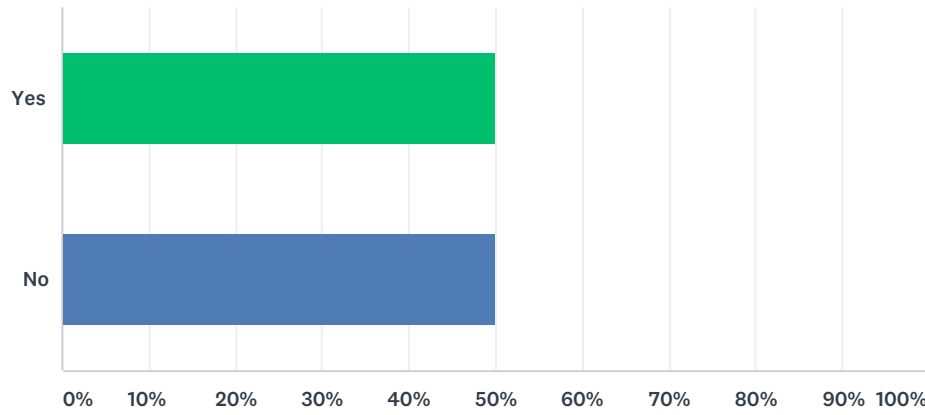

Q6 Are you satisfied with your current monitoring system?

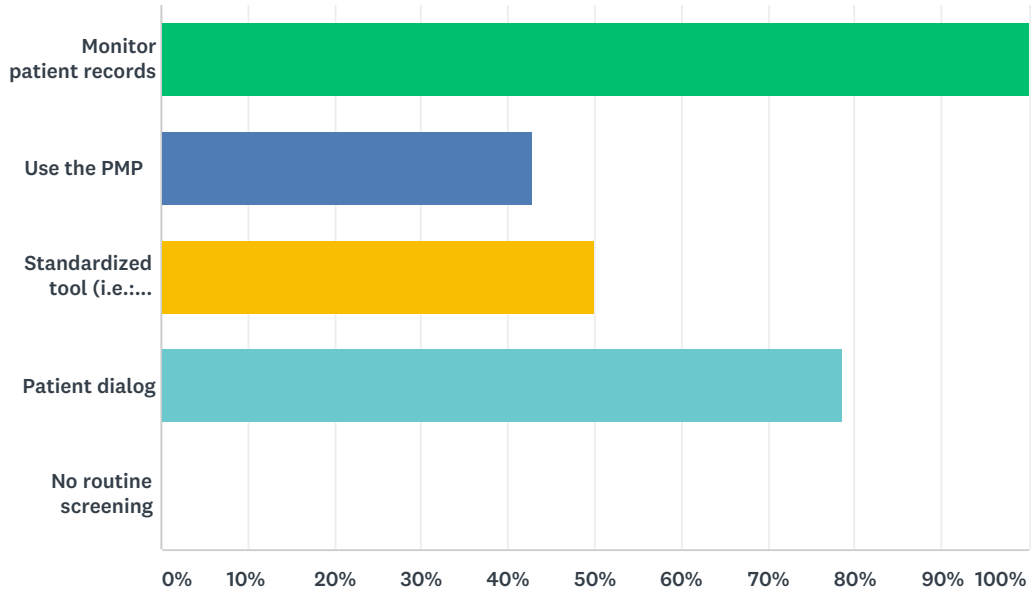

Q7 When you prescribe opioids, how do you screen for potential opioid use disorders? Check all that apply.

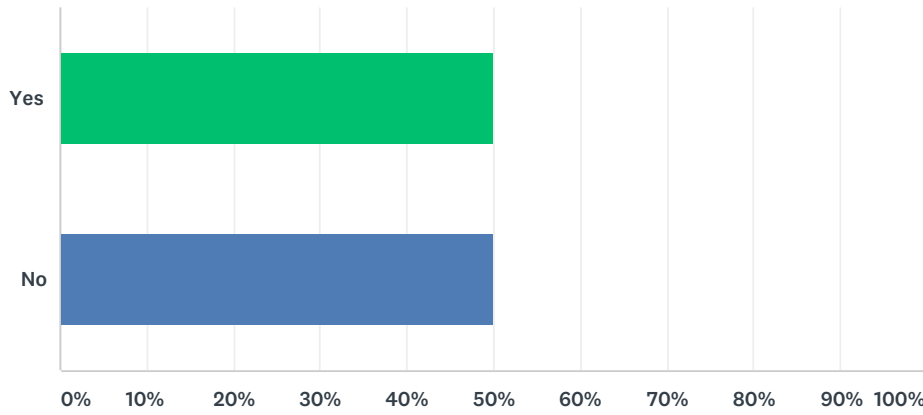

Q8 Are you satisfied with your current screening method?

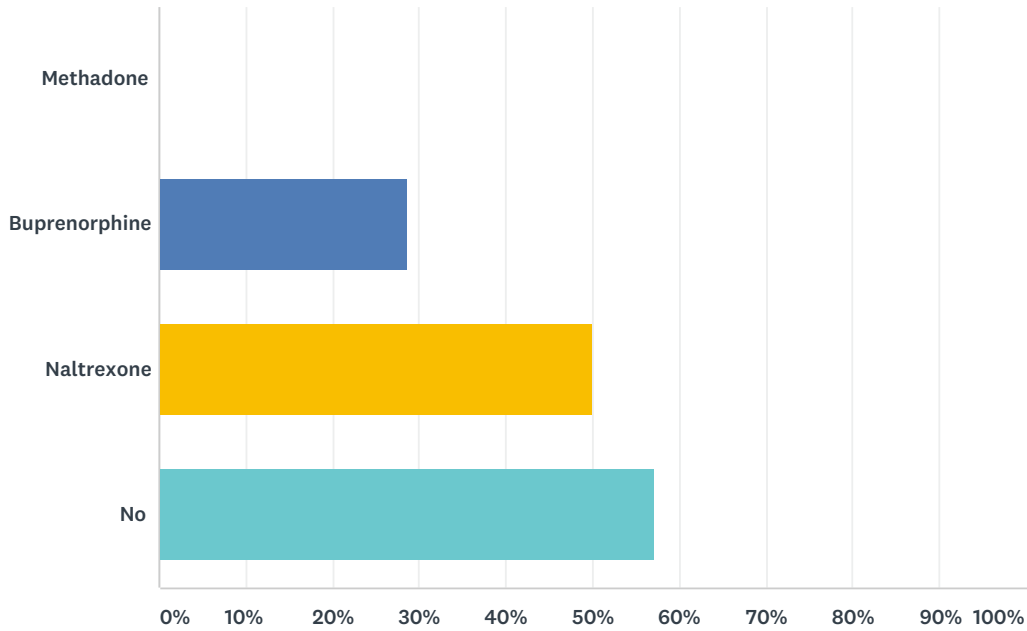

Q9 Are you licensed to provide either of these medications for opiate use disorders? Check all that apply.

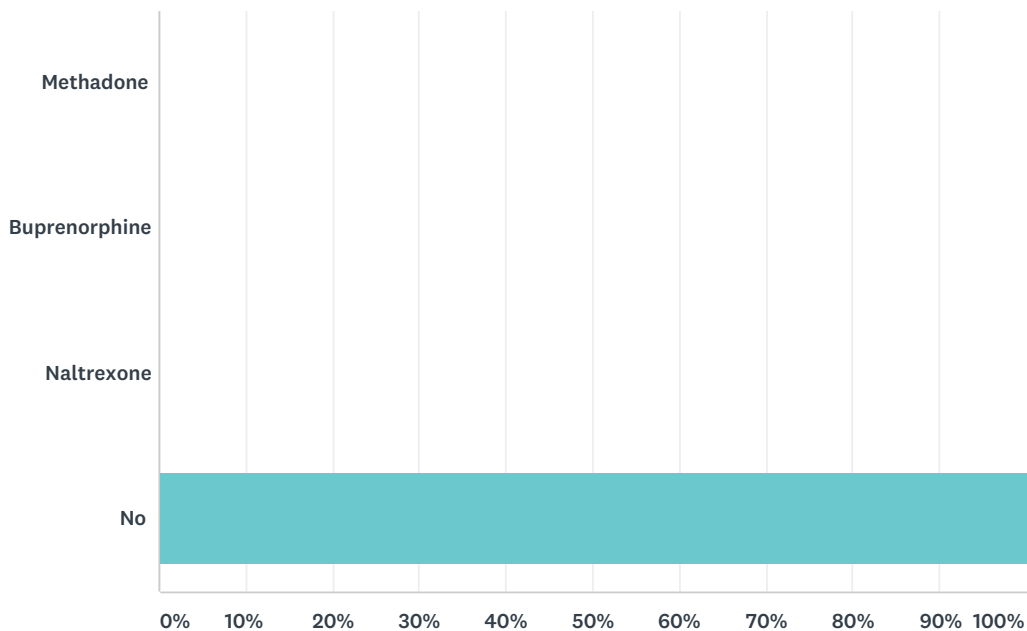

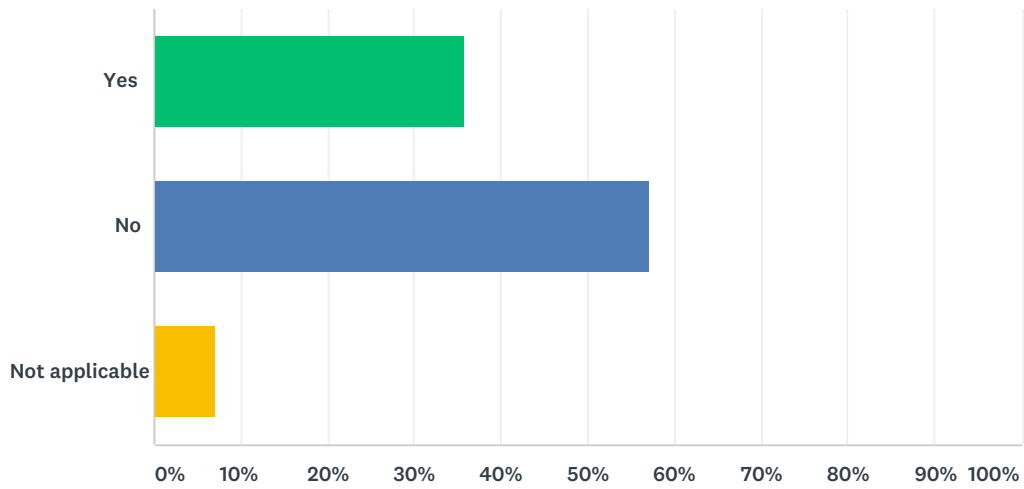

Q11 Do students in your school have specific education regarding opiate safety?

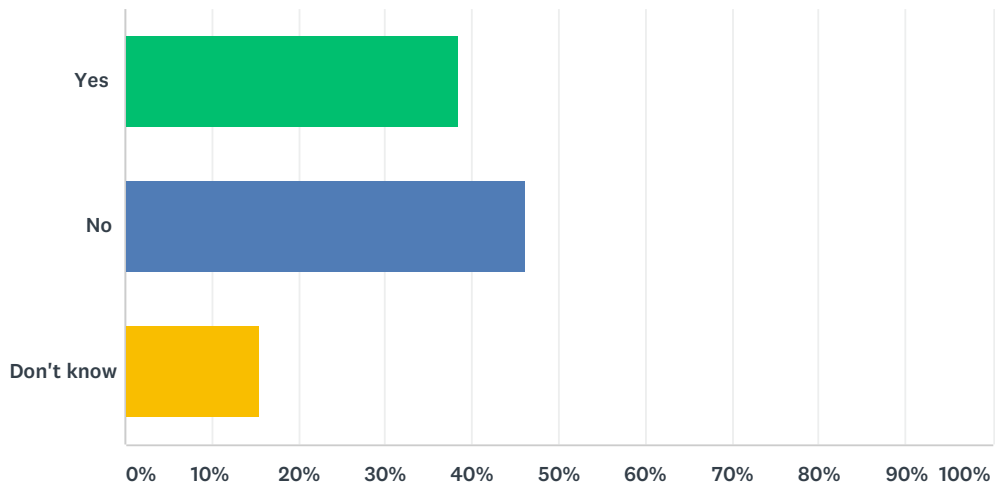

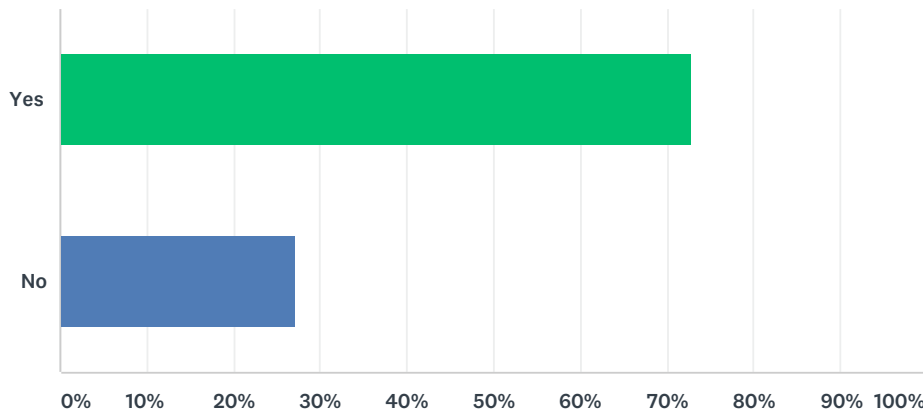

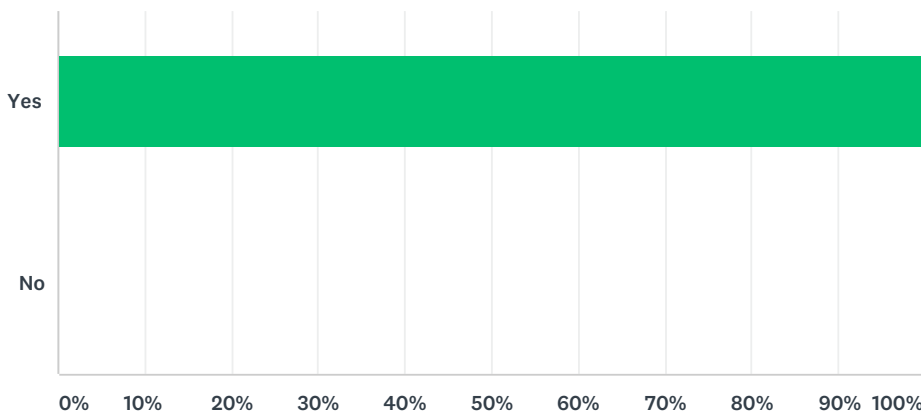

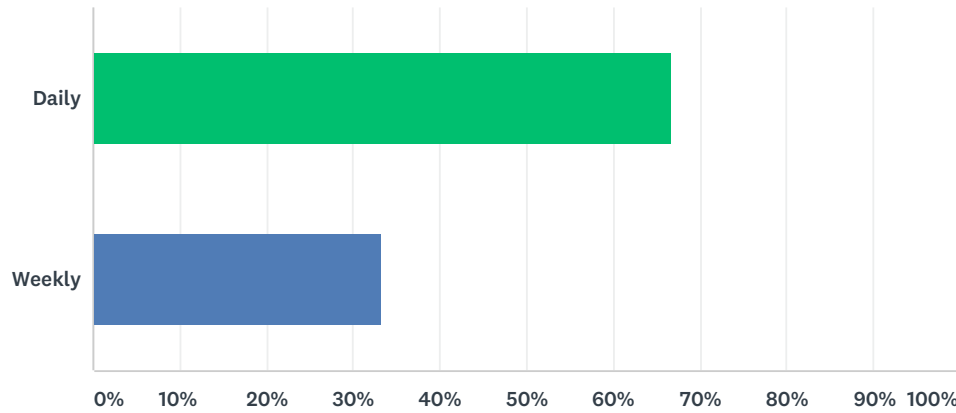

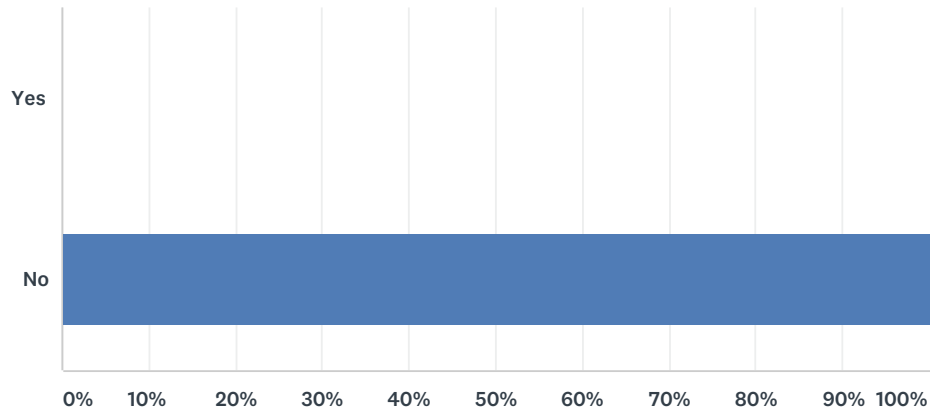

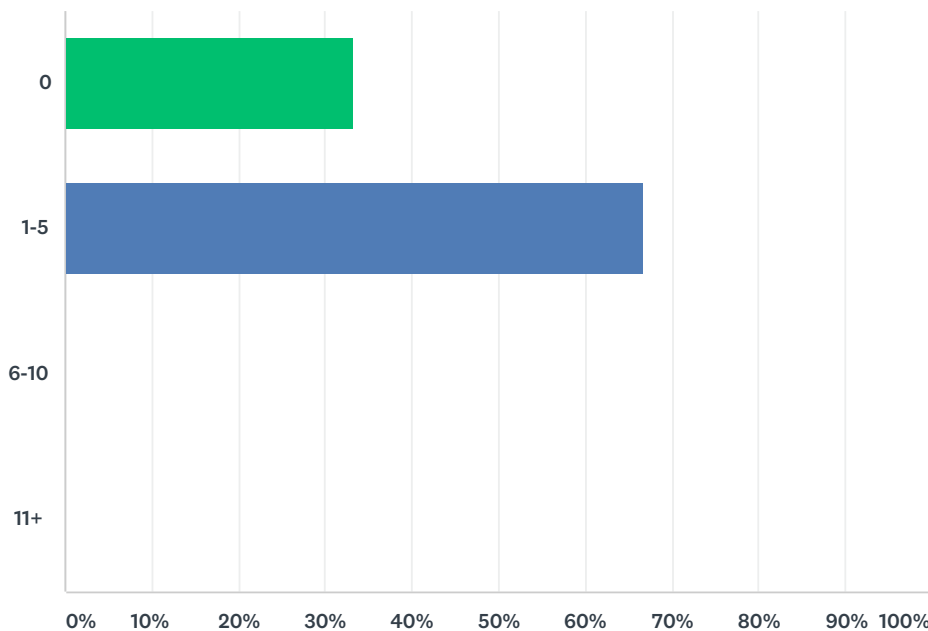

Q18 Approximately how many naloxone kits do you dispense each month?

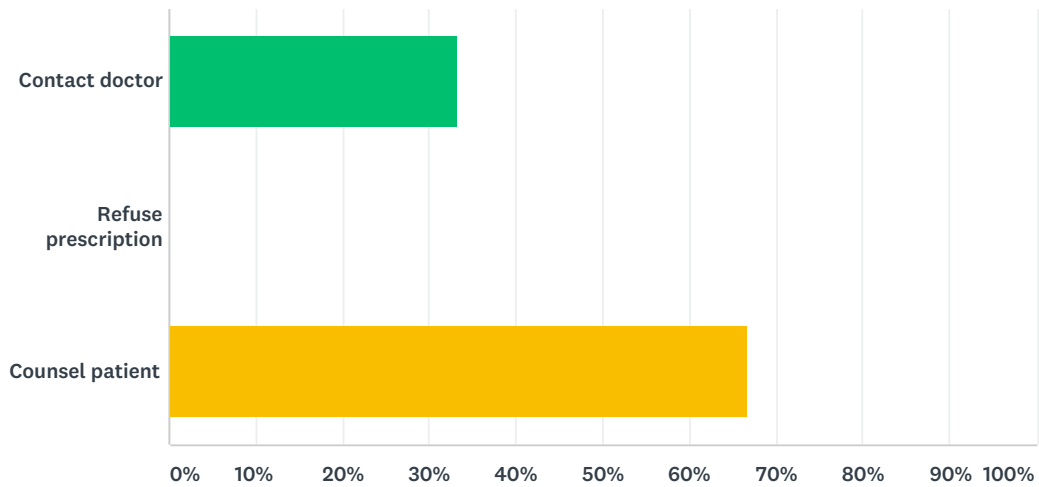

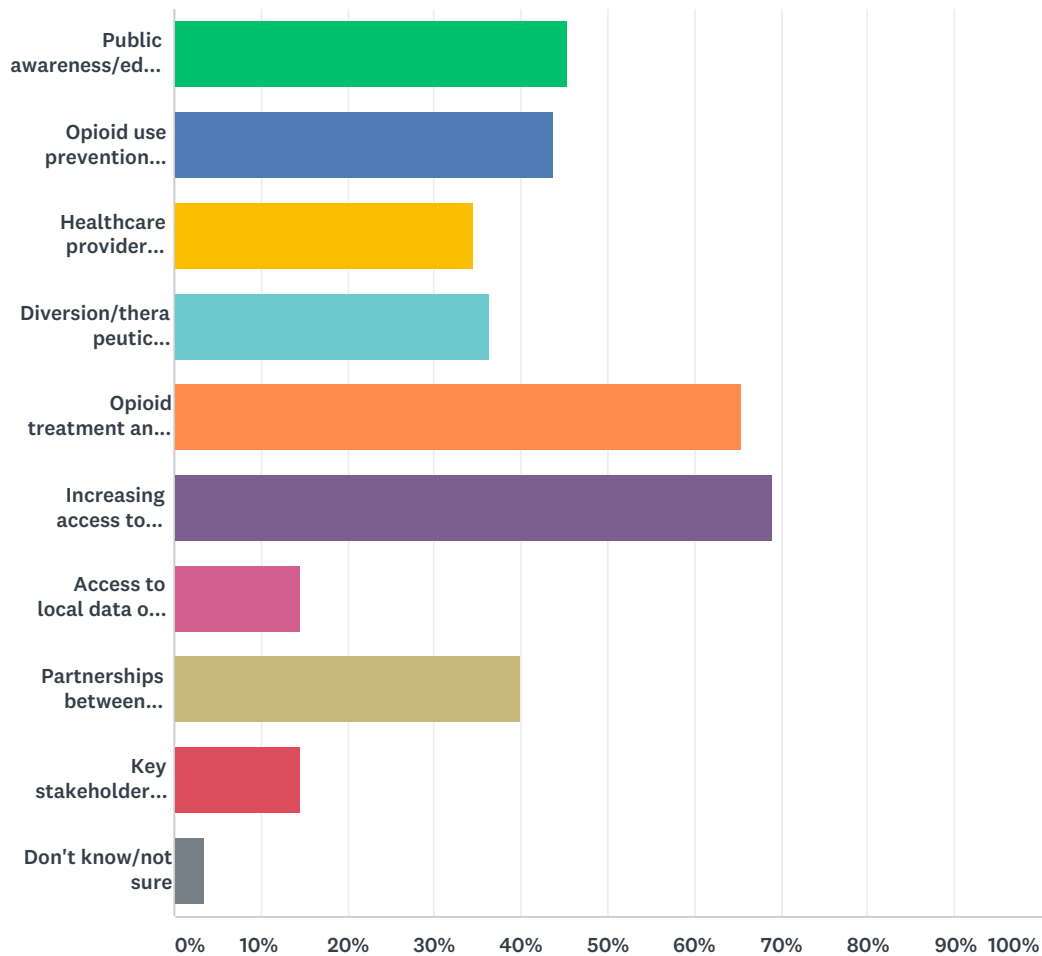
